Ag Georgia Farm Credit Classic

Tift County Livestock Multipurpose Building - - - Tifton, Georgia December 7, 2019

- 1. This show is for Market Steers, Commercial Heifers and Registered Heifers.
- 2. Exhibitors must be 4-H or FFA members at the time of entry. **An exhibitor must be in 4th grade as of September 1, 2019.**
- 3. All entries must be postmarked by November 27th, 2019 and mailed with entry fees of \$25 per head. Late entries will be received after November 27th until December 6th will pay a \$35 entry fee per head. Late entries on check-in day will be accepted for \$40 *CASH ONLY. No entry fees will be refunded. These dates will be strictly enforced.
- 4. All entry forms must be filled out completely including ear tag numbers or tattoos. Birthdates must be included in heifer entry forms.
- 5. All entries must be signed by the participant's Agriculture Education teacher or county Extension Agent as well as by the parent or guardian. Otherwise, they will not be accepted.
- 6. All steers and heifers must be owned by the exhibitor.
- 7. Registered heifers-The original registration certificate must be presented at the time heifers are checked in at the show and tattoos will be checked. Registered heifers without registration certificates will not be allowed to show in registered classes. Registration certificate must be made out in the exhibitor's name. Farm name will not be acceptable. Registration number must be assigned prior to November 1, 2019.
- 8. All steers and commercial heifers must have a state ear tag.
- 9. Commercial and Registered heifers should be born on or after January 1, 2018
- 10. All animals must meet the health regulations according to the State Department of Agriculture Health Regulations. The show committee strongly recommends that heifers be calf hood vaccinated for brucellosis.
- 11. Registered heifers will be shown by age and possibly breed, depending on entries. Commercial heifers will be shown by weight.
- 12. All animals must be halter broken. Any steer or heifer that breaks loose from the exhibitor 3 times while in the show ring will be disqualified.
- 13. Prize money will be awarded based upon available funds.

- 14. Fitting is optional
- 15. Substitute showmen must be 4-H or FFA members, and be approved by a show official. No adults other than show officials will be allowed in the show ring.
- 16. Each participant in the showmanship must own the calf they show in showmanship. No Exceptions!
- 17. Exhibitors must keep the part of the building occupied by them neat and attractive in appearance. Participants may be held responsible for any damage caused by them to the premises.
- 18. No blocking chutes will be allowed in the arena area.
- 19. Rules and compliance: Anyone failing to comply with any rules of the show will forfeit any prize money, trophies, and ribbons won.
- 20. Grievances will be heard and ruled on by the show committee. A \$50 deposit must accompany every grievance before it is heard and ruled upon. If the committee rules favor of the individual's grievance, the deposit will be returned: if not, the money is forfeited to the show.
- 21. The show committee reserves the final and absolute right to interpret these rules and regulations.
- 22. Steer & Heifer Check-in: 7:30-9:00am.
- 23. Showmanship starts at 10:00am. Showing youngest to oldest.
