Practice Ammunition Purchase Opportunity: The coaches will have a limited supply of boxes of shells available for purchase by 4-H'ers **IF** the 4-H'er is unable to find shells on their own. This will be limited to 1 box of shells per 4-H'er per Tuesday and Thursday practice, and is only for use at practice. The purchase opportunity is not available on additional, optional Saturday practices.

Practice and District Fees do not include travel to and from district match or meals.

State Competition Fees do not include travel to and from state match, meals, or lodging. Participants will have the opportunity to pay an additional \$25 to stay at Rock Eagle the night of May 12th. Parents will be responsible for their own lodging at a nearby hotel the night of May 12th.

Practice and District Fees: do not include travel to and from competition or meals.

Payment must be made before a student can practice.

State Competition is a separate fee of \$50.00, which includes: clays used during practice, state competition registration and ammunition for state competition. (\$50 does NOT include housing fee for night before competition). **State Competition Fees** do not include travel to and from competition, meals, or lodging.

Participants will have the opportunity to pay an additional \$25 to stay at Rock Eagle the night of May 12th.

Parents will be responsible for their own lodging at a nearby hotel the night of May 12th.

Dade County Shotgun Rules & Regulations

1. No student or parent is to enter the practice location prior to a coach's arrival and only a coach is allowed to unlock the gate.
2. No guns or ammunition, neither personal property nor 4-H property, are to be handled by any student or parent at the practice location prior to coach's arrival or after coach's departure from practices.
3. No students or parents are allowed on the firing line or beyond the firing line, unless specified by a coach.
4. No student or parent is allowed inside or on the County 4-H Trailer holding equipment and ammunition unless permission is given by a coach and under the coach's direct supervision.
5. No student or parent is allowed to handle a gun or shoot a gun until a coach has arrived and the official practice has started.
6. All gun safety rules and regulations that will be presented in the first two practice sessions will be upheld and followed at all times. Failure to abide by the rules can result in discharge from the team.
7. All students will have 3 available strikes at practice. If they reach the third strike, that student will be asked to leave practice and depending on their offences, could be suspended from one or more future practices. (Examples: Foul language, Inappropriate behavior, Bullying, Safety Rule Violation, etc.....)
8. All students and parents will be respectful and follow the direction of the certified coaches.

By signing this document, students and parents are agreeing to the above stated rules. Failure to abide by these rules, either by a student or the parent of the student, will result in the student being discharged from the team and no registration money will be refunded.
