Only two animals can be entered per class by an exhibitor and not more than four breeding sheep can be entered in the entire show. Entries must be made online by the county agent for 4-H entries or by the agricultural education teacher for FFA entries by December 5, 2020. An entry form must be printed from the online entry site to be signed by the parent, agent/teacher and the exhibitor and sent with correct entry fee(s). Copies of the entries and the correct fees must be postmarked by December 12, 2020 for the entry to be complete. All entries from a county or chapter must be mailed together with one check or money order for all of the entries from that county or chapter. No individual checks will be accepted. NO EXCEPTIONS. Entry fees are \$15.00 per ewe and must accompany the signed form.
