An Exhibitor may enter up to five (5) does but will only be allowed to bring a maximum of three (3) to the State Show. **Entries must be made online** by the county agent for 4-H entries or by the agricultural education teacher for FFA entries by December 5, 2020. An entry form must be printed from the online entry site to be signed by the parent, agent/teacher and the exhibitor and sent with correct entry fee(s). Copies of the entries and the correct fees must be postmarked by December 12, 2020 for the entry to be complete.

**All entries from a county or chapter must be mailed together with one check or money order for all of the entries from that county or chapter. No individual checks will be accepted. No exceptions.** Entry fees are \$15.00 **per doe** for the first three (3) does and \$25 for the 4<sup>th</sup> and 5<sup>th</sup> doe and must accompany the signed form.
