All goats must be owned by the exhibitor on or before *August 1, 2020*. Entries must be made online by the county agent for 4-H entries or by the agricultural education teacher for FFA entries by August 1, 2020. An entry form may be printed from the online entry site to be signed by the parent, agent/teacher and the exhibitor and sent with correct entry fee(s) or this entry form (signed by the parent, agent/teacher and exhibitor) may be mailed with the correct entry fee(s.) Copies of the entries and the correct fees must be postmarked by August 8, 2020 for the entry to be complete. Entry fees are \$15.00 per goat for the first 3 goats and \$25/goat for the 4th and 5th goat. ALL ENTRIES FROM A COUNTY OR CHAPTER MUST BE MAILED TOGETHER WITH ONE CHECK OR MONEY ORDER FOR ALL OF THE ENTRIES FROM THAT COUNTY OR CHAPTER. NO INDIVIDUAL CHECKS WILL BE ACCEPTED. NO EXCEPTIONS. Entry fee must accompany the signed form.
