



2025 Georgia 4-H State Horse Show

Intent to Show Form Directions

*****Please pass this information along to your Horse Club Leader(s)! No other notification will be provided.**

FOR 2025: Once again, County Extension Personnel will be responsible for entering all Intent to Show Forms for the State Horse Show online. Here is how it will work:

- Provide 2025 Intent to Show Forms to all 4-H'ers interested in participating in the 2025 State 4-H Horse Show. 4-H'ers must return the completed Intent to Show Form with a color photo of the entered horse to the County Extension Agent by a date designated by the County Extension Agent before March 14th.
- All **Intent to Show Forms** must be submitted online by the County Extension Agent by **5:00 pm on March 14, 2025**. No changes or additions will be allowed after this date. Please submit all possible horses in ownership in case of injury. Please remember that a horse may be carried as a project animal by up to 2 4-H members and shown by up to 2 4-H members, provided they are in different age groups. Still, each horse/rider combination must submit separate Intent to Show Forms.
- Once the County Extension Agent receives a complete Intent to Show Form (all signatures, proper size/color photo, and appropriate proof of ownership must be attached), the county agent will go online to the Horse Show Registration Site (<https://secure.georgia4h.org/horseshow>) and enter each individual Intent to Show Form. Once all information is entered, please upload each completed Intent to Show Form with support material (proof of ownership). **Please do not upload Coggins at this time.**
- By signing the Intent to Show Form, the County Extension Agent certifies that the horse designated on the Form is owned or leased by the designated 4-H member, parent, or legal guardian and has been obtained as a 4-H project before March 1, 2025. Verifying this information is the sole responsibility of the signing County Extension Agent.
- Once the online Intent to Show Entry is complete, the County Extension Personnel is responsible for keeping all of their respective county's Intent to Show Forms on file at their office, **Do Not Send Forms to Athens**. The County Extension Staff may be required to provide specific documents at the request of State 4-H Staff, The University of Georgia, and Animal Science staff at any time.
- After March 14, County Extension Personnel will receive an email notification that the 2025 Intent to Show Form registration is finalized and give the agent the opportunity to visit the Horse Show Registration Site to view their county's possible horse/rider combinations that are eligible for the 2025 State Horse Show. This will probably occur after April 1, 2025.
