Mechanical Bull Riding Release of Liability, Waiver of Claims, Express Assumption of Risk and Indemnity Agreement

Ι,	do hereby affirm and acknowledge that I have been fully informed of the inherent
hazards and risks associated	with bull riding activities to which I am about to engage, including but not limited to

- 1. Shoes must be removed and pockets emptied before entering ride.
- 2. DO NOT HOLD THE HORNS OR ANY PART OF THE BULLS HEAD, only hold on to the rope.
- 3. ONLY 1 RIDER PER TURN, NO DOUBLE RIDES. THERE IS A 300# weight limit on the bull!
- 4. No food, drinks or smoking within 15 feet of the unit
- 5. NO face, body or face paint allowed on the unit. This includes any hair color that is NOT natural, any type of face paint or body paint or make up that is used to draw on the face or body such as cat whiskers, noses or anything that is NOT natural. We are not hair stylists or make up artist therefore we will not try to determine what type of materials are used. This rule applies across the board regarding any type of face, hair or body paints or coloring.
- 6. The rotation and bucking movement of the mechanical bull which will cause me to fall off of the bull in an uncontrollable manner.
- 7. The changing condition of the equipment used during the bull ride. The ground surface, and the speed and movement of the bull.
- 8. Inclement weather, lightning, variances and extremes of wind, weather and temperature.
- 9. My sense of balance, physical condition, ability to ride and hold on or follow directions.
- 10. Equipment failure or operator error.
- 11. THERE IS a 300-pound weight limit on the bull. This is to maintain the integrity of the equipment and structure of the unit.
- 12. In the event of rain or inclement weather the mechanical bull will be taken down immediately. Once taken down the unit WILL NOT go back up!

I understand that the above described risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Furthermore, Your Event Moonwalk Rentals, LLC employees seek safety but are not infallible. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions and the equipment might malfunction. I have read, understand and agree to abide by ALL bull riding instructions at all times and I certify that I am physically/ mentally able to participate in the bull riding activity to which I am about to engage. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury to myself. I further certify that I am willing to assume the risk of any medical or physical condition that I might aggravate or cause myself.

I specifically waive any defense as this contract is concerned that may arise as a result of any law and/or regulation or policy that may impact its enforceability. I agree to waive and release any and all claims based upon negligence, active or passive, that I may have in the future against all of the following named persons or entities here in referred to as releases: Your Event Moonwalk Rentals, LLC, its owners, and employees.

By entering into this agreement, I am not relying on any oral or written representation or statements made by the releases, other than what is set forth in this agreement.

I hereby declare that I am of legal age and am competent to sign this Agreement or, if not, that my parent or legal guardian shall sign on my behalf and that my parent or legal guardian is in complete understanding and concurrences with this Agreement.
