### General Information:

- Shotgun team is open to 6th - 12th grade Paulding County students (Public, Private, and Home School)
- Shotgun team interest meeting: Thursday, January 16, 2025 at 6:00 PM at the Paulding County Extension Office
- Registration: January 20<sup>th</sup> – 24<sup>th</sup> (Must turn in Enrollment Card, Medical Information & Release Form (MIRF), and Code of Code)
- Safety Meeting: Conducted at the first consolidated practice on January 26<sup>th</sup>
- Team will be capped at 25 shooters
- 4-H'ers must successfully complete a State Department of Natural Resources Hunter Education Program.

### Activity Fee:

- \$250.00 per year Due NLT February 14<sup>th</sup>
- Payments **cannot** be paid at practices
- Acceptable forms of payment are cash, check, Visa, MasterCard, or money order. Payment can be provided over the phone or by visiting the Extension Office.
- Make checks payable to *Paulding County 4-H*

**Equipment:** 4-H'ers are responsible for the purchase of their own equipment.
